LivaNova PLC (the "**Company**" or "**LivaNova**") announces on 09 December 2016 the repurchase of 38,000 ordinary shares on 08 December 2016 as part of the amended share repurchase programme announced on 15 November 2016. The highest price paid per ordinary share was \$45.48 and the lowest price paid per share was \$44.69. The repurchased shares will be cancelled. As of 08 December 2016, after giving effect to the cancellation of these ordinary shares, the number of shares of ordinary shares outstanding would be 48,255,642, and the total number of voting rights in the Company would be 48,255,642, which may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in the Company under the FCA's Disclosure Guidance and Transparency Rules.
