Explanation of Responses:

1. Due to an administrative error, LivaNova PLC (the "Company") failed to include on the original Form 3 certain derivative securities owned by reporting person as of June 12, 2017. This amended Form 3 is being filed to provide the omitted information.
2. Each restricted stock unit (RSU) represents a contingent right to receive one ordinary share ("Ordinary Share") of the Company, GBP 1.00 par value, in accordance with the terms of the LivaNova PLC 2015 Incentive Award Plan (the "Plan") and the terms of the award agreement.
3. On June 12, 2017, reporting person was granted RSUs subject to a four-year vesting schedule, vesting 25% on each of the first four anniversaries of the grant date subject to continued service during the vesting period and the terms of the award agreement.
4. On June 12, 2017, reporting person was granted an award of stock appreciation rights ("SARs"). Subject to the terms and conditions of the Plan and the terms of the SAR Agreement, the SARs shall vest in equal installments of 25% on each of the four anniversaries of the grant date.
